Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal, except:

1. When the electrical system rating does not exceed 400 amps and the building is not over 3,500 square feet in area.
2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

**V. APPLICANT SIGNATURE**

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subjected to civil fines.

## VIII. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Provide all information required in items 1 thru 7, paying special attention to items 5 and 6. The electrical permit, when issued, entitles the holder to one (1) electrical inspection. All additional inspections or reinspections necessary must be included in Items 27 and/or 28. Items, quantities and inspections that are overlooked, unforeseen, or omitted from the original permit application will be billed to the permit holder. These additional fees must be paid prior to a final inspection being conducted.

Electrical work shall not be started until the application for permit has been filed with the Kimball Township Building Department. All installations shall be in conformance with the State Electrical Code. No work shall be concealed until it has been inspected.

The telephone number for the inspector is provided on the previous page of this application. When ready for an inspection, call the inspector providing as much advance notice as possible. When requesting any inspection, have the job site address and permit number ready.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX (6) MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.
